Thank you for your support of Catholic Charities this past year. With God's grace and your support, we are

changing and saving lives. During the pandemic, we adapted how we serve for the safety of our staff and clients, but we never stopped serving because of COVID. We sold underutilized properties, renovated others and moved our Pinellas County immigration and pregnancy offices to Clearwater to be more centrally located and accessible to clients. In heroic ways, we alleviated suffering and found creative ways to bring people hope through our three:

We housed or sheltered over 4,000 people and continue to work towards our Courageously Living the Gospel goal to create more affordable housing. In May we had a Blessing Ceremony on the grounds of Mercy Oaks Apartments as City of Tampa staff, City Council members and Hillsborough County Commissioners joined us. We were also blessed in October to open the Pasco Family Shelter, a shelter for young homeless families with children. We will soon be opening two additional communities of affordable housing—Las Villas in Ruskin and Vincent Oaks in Tampa. And after several delays, we expect to begin construction in 2022 on St. Benedict Apartments in Crystal River.

We provided nearly \$3 million in rent and utility assistance to over 2,000 families that suffered directly due to COVID. We served over 2,000 immigrants seeking citizenship. Our Free Medical Clinics directly served nearly 1,000

patients with nearly 3,000 appointments. In June, we held a Ribbon Cutting and Blessing Ceremony for a new, larger home for the La Esperanza Free Medical Clinic that will allow us to expand services. Previously, it shared space at Our Lady of Guadalupe Mission in Wimauma.

Our pregnancy and adoptions programs served nearly 2,000 women. One highlight was the September blessing of the new Mobile Medical van which was donated by various Knights of Columbus councils. The September Ribbon Cutting and Blessing Ceremony was both joyful and tearful as we named the van, “Barb” after our late, long-time ultrasound nurse, Barb Cowne. The van will allow us to reach more women.

Finally, we are pleased to share that our long-time goal of opening a permanent homeless shelter is moving forward. We worked with the City of Tampa to purchase a property in East Tampa, and we hope to be partially open by Christmas with up to 50 beds. When completed, we hope to provide safe housing for 300 homeless men and women.

Catholic Charities was created in 1945 by Bishop Joseph P Hurley as the Tampa Office for Charity. It was operated under the auspices of the Diocese of St. Augustine as one of three regional offices, collectively known as Diocesan Catholic Charities, under the charter of the Catholic Charities Bureau, Inc. It was created to relieve the burden on Catholic parishes which were struggling to meet the needs of the poor in their communities at the end of World War II. The present Catholic Charities was created as a nonprofit corporation in June 1968 when the Diocese of St. Petersburg was established.

Our mission is driven by the Gospel mandate to serve those most in need by fulfilling Christ's Corporal Works of Mercy. Catholic Charities continues to provide the highest quality social services designed to preserve families and promote self-sufficiency and social justice while operating under three Ministries of Mercy: Foundations of Life, Friends in Need, and Shelters of Hope.

CATHOLIC CHARITIES IS GOING MOBILE TO SAVE LIVES

On September 24, 2021, Bishop Gregory Parkes and Catholic Charities of the Diocese of St. Petersburg held a Ribbon Cutting and Blessing Ceremony for the new Mobile Medical Unit in front of the Foundations of Life Pregnancy Center on Armenia Ave, Tampa. This new pregnancy center on wheels will extend the reach of the four pregnancy center locations operated by Catholic Charities and make services more accessible to women throughout the Diocese of St. Petersburg, but primarily in Hillsborough and Pinellas counties. The goal is to serve low-income, uninsured women who are either pregnant or believe they may be pregnant. The custom-designed Mobile Medical Unit will offer an array of services and assistance at no cost to those experiencing an unplanned or crisis pregnancy. These services include FREE on-site pregnancy tests, ultrasounds, life options counseling and referral services (e.g., Medicaid, WIC, etc.). For more than 25 years, Catholic Charities has provided free pregnancy services to

underserved women within the Diocese of St. Petersburg. Beginning in 2000 in St. Petersburg as Pregnancy Services Plus, the centers subsequently expanded to Tampa, Dade City and Spring Hill. In 2016, the Knights Women's Center was opened in Tampa.

"Establishing a Mobile Medical Unit shows our unwavering commitment to serve the most vulnerable in our communities. We never lost sight of the impact that a mobile medical unit would have for those in need of our services who could not easily travel to one of our existing pregnancy centers," said Maggie Rogers, Catholic Charities Executive Director.

"The Mobile Medical Unit features tinted windows and privacy shades, 360-Degree security monitoring, multiple seats for counseling, a cushioned sonogram table, a restroom for pregnancy testing, and even planned pregnancies," said Ramos.

Foundations of Life Pregnancy Centers strive to reach women who are being targeted by the abortion industry; socioeconomically challenged minorities, students, migrants, and others in the primary age range of 14 to 32. In the past year alone, over 9,000 innocent preborn children lost their lives to abortion in the Tampa Bay area. Within Hillsborough and Pinellas counties, there are eleven abortion facilities.

"When we say we want to help women, we mean we want to help women for life. Through the Mobile Medical Unit, women will be able to join our programs, receive free services, and be referred for housing and medical assistance. We are the bridge that connects our diocese to these women," said Ramos.

For two years, Jose Posada has relied on services provided by Catholic Charities at the La Esperanza Free Medical Clinic in Wimauma. Without this assistance, he would have had to face his medical condition alone and his health would likely have deteriorated.

"My medical condition has been very difficult, but I have hope. Catholic Charities has been a big support to me. I am grateful to everyone who has been there for me. Words can't express my gratitude," said Posada during a ceremony on June 30th to celebrate the blessing of a new building for La Esperanza. The clinic is operated by Catholic Charities of the Diocese of St. Petersburg in partnership with BayCare Health System, St. Joseph's

Hospital South, and support from other community partners and individual donors.

"Our medical clinics have been open for 20 years. We have served thousands of people and saved hundreds of lives and it's because of our partnerships," said Maggie Rogers, Executive Director, Catholic Charities.

The new building for La Esperanza, which means "hope" in English, is an expansion from the temporary space "borrowed" from the nearby parish of Our Lady of Guadalupe Mission. Catholic Charities previously saw patients in converted classrooms or a mobile bus parked on the church campus. This new building will open new doors to improving lives.

"What this means is greater access and greater resources that can be brought into the community. That's what was holding us back in borrowed space," said Sister Sarah Proctor, a religious sister of the Daughters of Wisdom. She helped to establish Catholic Charities' three free medical clinics in the Diocese of St. Petersburg. Services include primary medical care, routine well-woman exams, health promotion, disease prevention and health screenings for high blood pressure and diabetes.

La Esperanza is open every Tuesday evening. Registration begins at 4:30 p.m. and the doors stay open until everyone has been helped. Clients must meet federal poverty guidelines and all the services are provided free of charge.

"This clinic we are opening today should enliven our faith and make us grateful because this clinic offers us the opportunity to live the Gospel," said Father Aloysius Ezenwata, Director of Mission, BayCare Health System. "Whenever we look to the interests of our neighbors or the community and serve them, we are in a sense serving Christ himself."

The clinic has grown dramatically since first opening in 2013. The first year, 121 patients came to the clinic for care. In 2020, nearly 700 patients were assisted. Since opening, over 3,500 patients have been served with over 6,000 patient visits.

"We're excited about the future of this clinic. Access to healthcare is one of the top three needs in Hillsborough County," said Philip Minden, president of St. Joseph's Hospital. "La Esperanza is one of BayCare's biggest investments in Hillsborough County for our community and we're excited to be a part of it."

During the ceremony, Monsignor Robert Morris, Vicar General of the Diocese of St. Petersburg, blessed the building saying, "Let us ask God's blessing on the La Esperanza Free Medical Clinic and the clients, healthcare professionals, and volunteers who will experience and share God's healing love here." Father Joel Kovanis and Father Aloysius Ezenwata also assisted with the blessing of the building.

Bishop Gregory Parkes joined Catholic Charities, as well as city and county leaders on April 28th to bless the construction site of the future Mercy Oaks Apartments, an affordable housing initiative of Courageously Living the Gospel.

"We believe as a church that this is part of our mission, that is what God has called us to do. Mercy Oaks is witness to

what can happen when mission and partnership and resources all come together to accomplish great things for our community," said Bishop Parkes during the ceremony.

Funding for this project in Tampa is made possible because of generous donors to the

Diocese of St. Petersburg and Catholic Charities and through a grant from Hillsborough County. Hillsborough County Commissioner Gwen Myers shared a sense of gratitude and pride for the project.

"I commend you today. We're happy to be a part of this blessing. Collaborative partnerships are the key to getting things done," said Commissioner Myers.

Mercy Oaks is expected to be completed by February 2022 and will house 20 working, low-income families.

Catholic Charities has been providing shelter to people in need since the late 1990s, assisting farm workers, seniors, people with AIDS/HIV and low-income. They have continued to expand their housing initiatives at the request of Bishop Parkes.

"In 2018, the bishop asked us to courageously live the Gospel by extending our services to those most in need. We have accomplished five additional affordable housing developments and aside from Mercy Oaks, we are working on three more affordable housing developments," said Maggie Rogers, Executive Director, Catholic Charities, Diocese of St. Petersburg.

Bishop Parkes spoke about the 20 units that will be built and said this project will make a positive difference to the 20 families who will call this community home.

Bishop Parkes blessed the Mercy Oaks construction site with holy water. Before sprinkling holy water on the grounds, Bishop Parkes led the participants in prayer. He said, "We need to give the glory and praise to God today for this and to ask for His continued blessing upon it."



"When someone has shelter, a safe place to life, a roof over their head, an address, they have a future hope and opportunity," said Bishop Parkes.

SHELTER IN THE STORM

**Catholic Charities Opens a New
Family Shelter for the Homeless**

A Pasco County mother and her four young children abruptly became homeless when their rental was deemed uninhabitable and in violation of county code. Although she had been paying rent, the landlord wasn't taking care of the structure and code enforcement officials determined it must be vacated. She along with her 11, 8, 5 and 2-year-old, children had no place to go.

Similarly, Curtis, a grandfather who is raising his granddaughter, following the death of his daughter, had only two days to find shelter. The trailer home they were living in was condemned for lack of care from the

landlord and it too had to be vacated. He and his granddaughter also had no place to go. They were the very first to arrive. Of the Pasco Family Shelter, Curtis says, "I've met some nice people here." He notes the "secure, clean environment" and says Catholic Charities is "considerate of [our] needs. "It's a spiritual development...and I'm learning to be a better person."

Stephanie and her three children, 3 year-old Riley, 5 year-old Leland and 7 year-old Jaylen, were alternating living in her mother's trailer and a motel her mother had paid for when she learned about the shelter. After a few weeks at the shelter, Stephanie says: "Since being here, Leyland has turned his ways around. "We can live a normal life. Always have somewhere to sleep. My kids love it here."

Now, that has changed and both families have somewhere to call home. They will be the first families to be welcomed into The Pasco Family Shelter, an emergency shelter for families in Port Richey providing free housing and services to homeless families of Pasco County.

At a blessing ceremony for the shelter and its residents, Bishop Gregory Parkes said, "This is what we do, this is our ministry as the Church. This is what we have been called to do and this shelter is one more example of what can happen when we partner together to solve a need in our local communities."

The first-of-its-kind shelter in the county, is the result of a partnership between Catholic Charities Diocese of St. Petersburg and The Coalition for the Homeless of Pasco County.

Nine families at a time will be able to obtain the services including transportation, basic medical care, housing and employment assistance and financial counseling to help families return to self-sufficiency. "Keeping families together is going to make the family stronger and they're going to have a better chance at overcoming the obstacles together," said Danielle Husband, Senior Director of Programs. Catholic Charities provides services to individuals from the start of life, to end of life and their shelters are truly a ministry of mercy taken up by many within the diocese.

"The success of Catholic Charities is really predicated upon the community support and our largest base of support are faith providers and the Diocese of St. Petersburg," said Husband, "The clients walk away knowing that the community loves them, and that's something that the Diocese offers. They bring that love and support into the shelters"

The shelter is not equipped with a full working kitchen and the biggest need going forward will be prepared meals for the families.

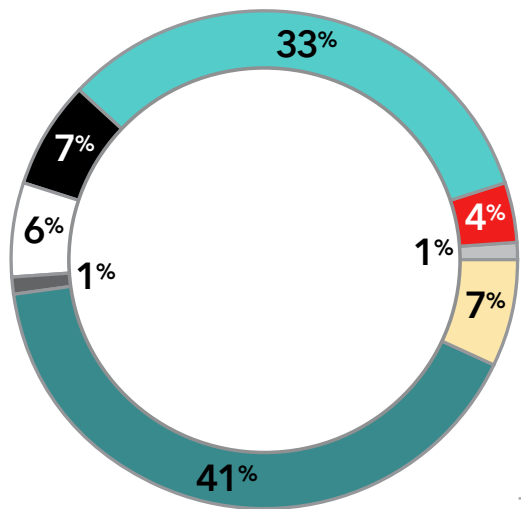

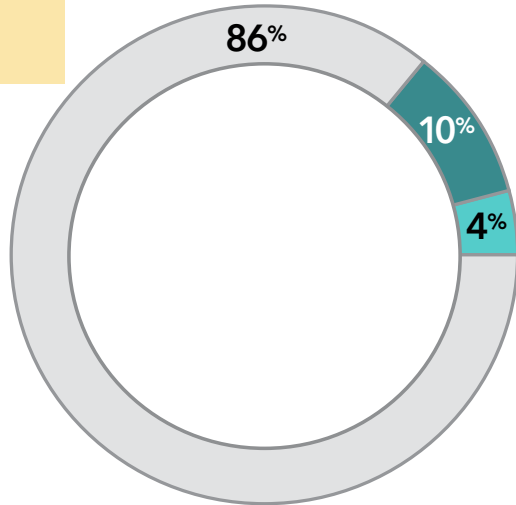

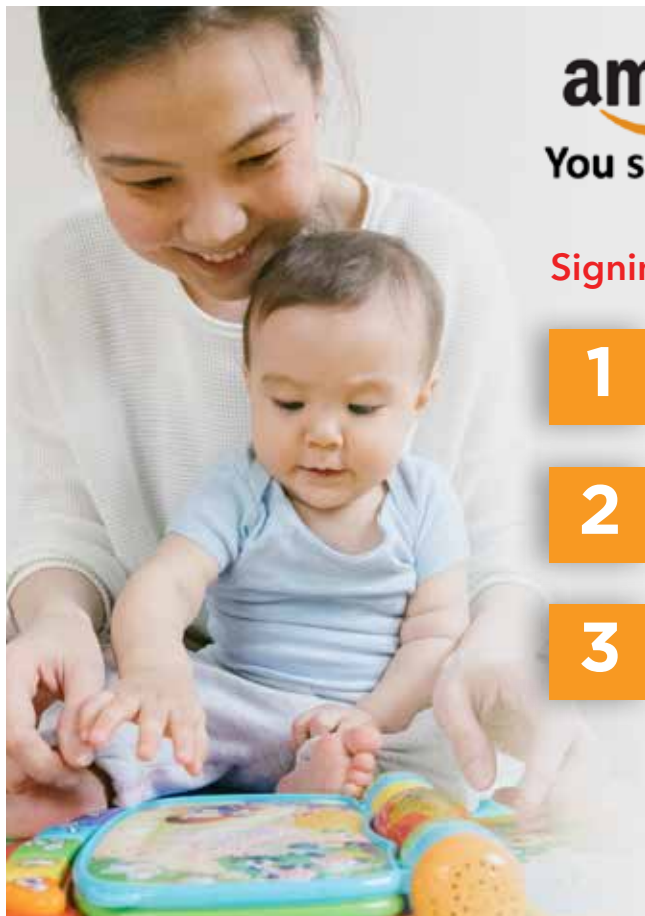
